## DECLARATION INSURANCE FOR PORSCHE

This following declaration shall form part of the questionnaire and the insurance contract. The purpose of this document is to provide information to the hosts who are offering the use of their Porsche to you. This same information will be used by the host's insurers to provide cover on the vehicle whilst it is in your care and thus will form the basis of underwriting of the insurance cover and contract. It is therefore important that the information you give is accurate and truthful. Any incorrect information will permit the insurance company to invalidate the policy and therefore in the event of an accident the vehicle which you are driving will not be covered and any damage to third party property will not be covered. In this event you will be responsible to indemnify any and each and every party to whom you have caused damage to property.

If you have any information which may affect the decision of the insurer to cover the vehicle whilst in your care please advise on this form.

It is also a condition of this policy that the vehicle will be used for private purposes only and shall not be used for hire or reward whilst the vehicle is in your care and control. The vehicle shall not be used for the purposes of racing, car club sporting activities or any other activities which will increase the exposure to the vehicle for damage.

It is further noted and agreed that the vehicle shall not be used on dirt roads or paper roads. No cover will apply if the vehicle is used and or damaged on the these roads.

The insured driver will comply with the rules and regulations of the New Zealand Transport Act and its amendments at all times. Any traffic convictions incurred by the driver at time of or during the use of the vehicle will be responsible for that fine and agree to indemnify the hosts for those costs.

**Use of information**

I understand that my personal information collected by Hadleigh Boutique Lodge may be:

- 1) Disclosed to their insurer and their insurance broker and to parties who have a financial interest in the vehicle to be insured.
- 2) Used to obtain insurance on the vehicle whilst it is in the undersigned's care, custody and control.

It is agreed that the information presented below is correct and we fully understand the parameters of use of the vehicle and that it shall be used **from** ..... **to** .....and shall be returned to its owners in the same condition as it was when received. Any damage to the vehicle whilst in our care will be subject to a motor vehicle claim and the excess will be applied which will be added to our account prior to departing the host's premises..

**Should this cover be accepted by the insurers a premium of \$120 + GST will apply per day. The excess each and every claim will be \$5,500.**
